Leapfrog Announces 2018 Top Hospital Award for North Texas Area Hospitals

Five DFW area hospitals receive coveted national distinction on safety & quality practices

DALLAS – Dec. 4, 2018 – [The Leapfrog Group](#) announced five North Texas hospitals have been named to its 2018 national list of Top Hospitals. The elite award is one of the most competitive honors American hospitals can receive in safety and quality. The winning facilities will be officially recognized at Leapfrog’s Annual Top Hospitals Ceremony tonight in Washington, DC.

Leapfrog is a national nonprofit watchdog organization that rates hospitals on how well they protect patients from errors and infections, as well as the effectiveness of procedures and other care they provide. This year, Leapfrog recognized 118 Top Hospitals across the country. Of those, 13 were Top Children’s Hospitals, 35 Top General Hospitals, 17 Top Rural Hospitals and 53 Top Teaching Hospitals.
